8. All the properties that are given and belong to the TRUST SHALL VEST IN THE **BOARD OF TRUSTEES**. The trustees in office shall not be liable to be removed from the office, except for breach of trust or misconduct.
9. The Trust shall be entitled and be at liberty to accept gifts of properties or any voluntary contributions from any persons or institution, or otherwise collect subscriptions or donations in the name of the TRUST to augment the resources Income and the Trust Fund and use of such money for the purpose and objects of the Trust. The **BOARD OF TRUSTEES** will be entitled to sponsor cultural, charity and social programme to raise funds. It shall always be open to the **BOARD OF TRUSTEES** in their absolute discretion to accept or reject any such donations, gifts and or contributions from any quarters ;
10. The Trust shall be exclusively managed by the **BOARD OF TRUSTEES** who shall have the powers of overall and day to day Management and administrations of the Trust.
11. The **BOARD OF TRUSTEES** shall elect among themselves a President, a Vice President, a Secretary, a Joint Secretary and a Treasurer for management of day to day affair of the Trust and their terms of office shall be for a period of three years from the date of assuming the office.

The following Trustees shall be the first President, Vice President, Secretary, Joint Secretary and Treasurer of the Trust.

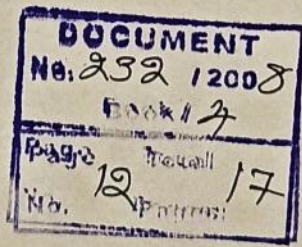



12. Powers and Duties of President, Secretary and Treasurer:

(a). PRESIDENT :

The president is the head of the trust and shall preside over the meetings of the trustees. In the case of equality of votes, the President shall have casting vote in addition to his vote. The President shall sign the minutes of the Board of Trustees meeting. The President shall represent the Trust for purchase of Immovable properties and legal proceedings before any authorities including the Court.

(b). VICE PRESIDENT:

In the absence of the President, Vice President shall assume the powers of the President.

(c). SECRETARY:-

The Secretary shall carry the correspondence on behalf of the trust. He shall be the custodian of all the properties of the trust, Movable or Immovable. The Secretary shall functions as a Correspondent of the Schools, and Other educational Institutions Managed by Trust.

(d). JOINT SECRETARY.:

In the absence of the Secretary, Joint Secretary shall assume the powers of the Secretary.

(e). TREASURER:-

The Treasurer shall keep up to Rs. 25,000/- ( Rupees Twenty Five Thousand only) in his hand and deposit the balance in the bank account of the trust. He shall maintain proper vouchers and bills for the payments made and receipts for the donation received.

13. Without prejudice to the generality of the Power, the Board of Trustees shall have the powers;

- a) **THE BOARD OF TRUSTEES** and their successor Trustees shall open and operate Bank Accounts in one or more banks at PERUNDURAI or any other place as may be decided by them from time to time ;
- b) **THE BOARD OF TRUSTEES** shall have an Executive Committee for the Trust and other necessary staff for the administration and the Management of the Trust ;
- c) **THE BOARD OF TRUSTEES** shall maintain proper accounts and the same shall be closed each year on 31<sup>st</sup> March. The Accounts shall be audited by a Chartered Accountant every year. The Board of Trustees shall also maintain a minutes book for the Board Meeting and shall record the proceedings and their decisions on any of the matters of the Trust. There shall be meeting of Board of Trustees atleast once in three months;
- d) The quorum for the Board of Trustees meeting shall be one-half of the Trustees of Trust.
- e) The Board of Trustees on their decision shall have absolute power to deal with the Trust properties exclusive of the Power of Sale, Mortgage or Exchange. The Board of Trustees shall invest the Trust Funds in the best interests of the Trust and in accordance to the requirements of the Income-tax Law for the time being in force. The Income and Funds of the Trust shall be solely utilised towards the objects and no portion of it shall be utilised for payment to Trustees by way of Profit, interest, dividends etc.
- f) **THE BOARD OF TRUSTEES** can deal with and alter the nature of properties, investments and securities of the Trust from time to time. It shall be open to the Board of Trustees to sell, lease or exchange or mortgage any of the Trust Properties and utilise the sale proceeds and income obtained by such sale or lease or mortgage to carryout the object of the trust.



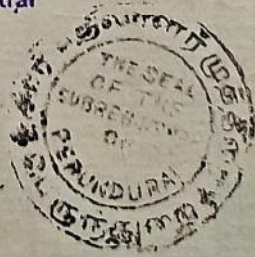

- g) The amount of donation or contribution to any individual or institution from the Trust fund shall be fixed and decided by the Board of Trustees ;
- h) The Board of Trustees shall have the power to borrow money or monies with or without interest and/or with or without security under their signature as Board of Trustees, if found essential to administer and manage the Trust ;
- i) The Board of Trustees will be entitled to claim all reasonable expenses incurred by them while managing / administering the Trust, and all such expenditure shall be entered / recorded in the Trust Account ;
- j) If at any point of time, the Board of Trustees decides to dissolve the Trust or merge it with any other trust, for any reason whatsoever, it shall be open to them to transfer the management of the trust and its properties to any other public charitable trust which has its objects similar to those of this Trust ;
- k) It is declared and understood that it shall be lawful for the Board of Trustees to resolve and frame the rules for the conduct and management of the Trust or Trust Fund or for the carrying out the objects of the Trust and such resolutions and rules framed, amended, altered or substituted shall have the same force as if they have been incorporated in the original Trust thereby created but not repugnant to the objects of the trust without such additions or alterations ( including any additional objects which may be incorporated there in ) impairing the eligibility of this Public Trust for the Income-Tax concession U/s.80-G of the Income-Tax Act.

17. The Trust shall be irrevocable;
18. There is no movable or immovable property at the time of execution.


